NOTIFICATION

The Governor is pleased to amend the 2(viii) of "Tripura Minority Patients (Financial Assistance) Rules,2018 as follows:-

- (i) A patient of Minority Community, having priority household/ Antodaya Yojana Ration Card as well as those whose Annual family Income is below Rs.1.20 Lakh will be eligible for availing the benefits under this scheme.
- (ii) A patient covered under "Ayushman Bharat" scheme will not be eligible for availing the benefits under this scheme.
- (iii) Before sanctioning assistance under this scheme, sanctioning authority shall certify in the sanction order that, the applicant does not have valid "Ayushman Bharat Card".


All other existing Rules of "Tripura Minority Patients (Financial Assistance) Rules,2018" including subsequent amendments, will remain unchanged.

2. Similar coverage criteria will be applicable for ST, SC & OBC patients.

This is issued as per approval of the Council of Ministers in its meeting held on 28th January,2021 vide Memorandum No.F.1(4)-GA(CAB)/2005 dated 1st February,2021.

This will take immediate effect.


