

**MAJOR DEVELOPMENT SCHEMES AND ACHIEVEMENT OF THE DEPARTMENT
ALONG WITH SCHEME DETAILS**

(A) EDUCATIONAL SCHEME

The main schemes under education sector are as under:-

1. Pre-Matric Scholarship:

OBC students of Class I to X get this scholarship @Rs. 150/- per month, for a period of 10 months in a year. The income bar for eligibility is not exceeding Rs. 2,50,000/- per annum as per guideline of Govt. of India. Funding pattern of this scheme is 50:50 i.e 50% Central Share and 50% State Share. Number of students benefitted under this scheme from 2018-19 to 2023-24 is as follows:-

2. Post-Matric Scholarship:

Student pursuing studies from class XI onwards upto College and University level under different category of courses are provided this scholarship for 10 months in a year and the income bar for eligibility is not exceeding Rs. 2,50,000/- per annum as per guideline of Govt. of India. Funding pattern of this scheme is 90:10 i.e 90% Central Share and 10% State Share.

- a) " Group 1: Degree and Post Graduate level professional courses" shall mean: all Professional courses in Medicine, Engineering, Technology, Planning, Architecture, Design, Fashion Technology, Agriculture, Veterinary & Allied Sciences, Management, Business Finance /Administration, Computer Science/ Applications (ii) Post Graduate, Diploma courses in various branches of Management & Medicine(iii)C.A./I.C.W.A./C.S./I.C.F.A. etc. (iv) M.Phil., Ph.D. and Post-Doctoral Programmes (D.Lit., D.Sc. etc.) of Group I, Group II and Group III courses .(v) L.L.B, Integrated LL B,L.L.M (vi) Commercial Pilot License Courses from Gol institutes (including helicopter pilot and multiengine) (maximum 20 slots per annum).
- b) " Group 2: Other Professional Courses leading to Degree, Diploma, Certificate" shall mean all Professional Courses leading to Degree, M Ed. / M. Pharma., Diploma, Certificate in areas like Pharmacy (B Pharma.), Nursing(B Nursing), BFS, other paramedical branches like rehabilitation, diagnostics etc., Mass Communication, Hotel Management & Catering, Travel/Tourism/Hospitality Management, Interior Decoration, Nutrition& Dietetics, Commercial Art, Financial Services (e.g. Banking, Insurance, Taxation etc.) for which entrance qualification is

minimum Sr. Secondary (10+2) and Vocational stream , ITI courses and Polytechnic where entrance qualification is Class XII or above.

- c) "Group 3: Graduate and Post Graduate course" shall mean: courses not covered under Group 1& Group 2 e.g. BA / B.Sc. / B.Com etc. M.A/ M. Sc./ M.Com etc.
- d) "Group 4: All post-matriculation (Post Class X level) non-degree courses" shall mean: All post-matriculation level non-degree courses for which entrance qualification is High School (Class X), e.g. Senior secondary certificate (class XI and XII); both general and vocational stream , ITI courses , 3 year diploma courses in Polytechnics, etc.

This is applicable for professional courses and candidates are selected from the list available in NSP 2.0 Portal for Post Matric Scholarship on merit basis and after invitation of application from the eligible OBC Students. The Tripura Other Backward Classes Cooperative Development Corporation Ltd. was established in the year 1996-97 and Registered under the Tripura Co-Operative Societies Act 1974.

The main object of the Corporation is to assist the poor OBC people of Tripura by providing loan with a very low rate of interest to establish micro enterprise/generate to attain self-sufficiency, to extend education loan to the students of backward classes for pursuing professional / technical education at graduate and higher level and for pursuing vocational course which will ultimately eradicate unemployment in near future.
